Participate in the implementation of program management cycle by:

- Prepare reports, articles and presentations during programme meetings, off-site visits and stakeholder engagement activities.
- Track and perform relevant analyses on various aspects of programme implementation to identify and address important challenges to ensure effective and efficient programme delivery.

Programme Support

- Represent SFA Foundation programmes at internal and external meetings when required.
- Work in close collaboration with SFA Foundation Communications Manager to develop a media and campaign Strategy for initiatives within the portfolio to ensure maximum exposure and coverage on the continent and beyond and to generate keen interest from potential stakeholders.
- Plan and organise relevant workshops and other activities in furtherance of the objectives of the projects within the portfolio.
- Develop a risk management framework for initiatives under the programme, including developing and maintaining a risk register for the programme and a system to document, track and ensure programme issues and challenges are resolved in a timely manner.

- Training in research administration, ethics, leadership or related will be an added advantage.
